
METHODOLOGY

- ➤ The value of assets decreased by 0.4% or 0.11 billion EUR in the 3rd quarter 2021;
- Total gross assets increased by 6% or 1.43 billion EUR in the last 12 months period.





Change of gross assets 30.09.2021. vs 31.12.2020., MEUR




Banks' gross assets 2000-2021* (1)







- Total capital of the Latvian banking sector was EUR 3.11 billion as of September 30, 2021;
- ➤ Total capital increased by 2.5% or EUR 0.08 billion in the 3rd quarter 2021;
- Total equity increased by 8% or EUR 0.23 billion in the last 12 months period and reached the largest value since 2018.





Change of capital 30.09.2021 vs 31.12.2020, MEUR




Banks' capital 2000-2021* (1)







Profit of Latvian banking sector

- Total unaudited profit of commercial banks in Latvia was EUR 202 million in 9 months 2021;
- ➤ It was larger by 88% or EUR 95 million compared to the result of 9 months 2020;
- ➤ Latvian banking sector is profitable since 2012;
- ➤ Accumulated profit of Latvian banking sector is EUR 817 million since 2008 (economic crisis) or in the last 14 years period.





Change of profit 9m 2021 vs 9m 2020, MEUR




Banks' profit 2017-2021*, MEUR un % from total profit of Latvian banking sector (1)





Banks' profit 2017-2021*, MEUR un % from total profit of Latvian banking sector (3)





- ➤ Total loan portfolio increased by 3% or EUR 0.38 billion EUR in the 3rd quarter 2021;
- The portfolio increased by 7% or EUR 0.96 billion in the last 12 months period.





Change of loans to private persons 30.09.2021 vs 31.12.2020, MEUR









Change of loans to companies 30.09.2021 vs 31.12.2020, MEUR




Banks' issued loans 2000-2021* (1)







- ➤ Deposits increased by 10% or EUR 1.70 billion in the last 12 months period.












Deposits at banks 2000-2021* (2)





Capital adequacy ratio 2012-2021* (1)





Capital adequacy ratio 2012-2021* (2)





Capital adequacy ratio 2012-2021* (3)





Return on equity 2017-2021* (1)





Return on equity 2017-2021* (2)





Return on equity 2017-2021* (3)





Return on assets 2017-2021* (1)




